20	Database LOB Objects	Need to handle the LOB objects to keep the better performance of all the applications
21	Cron jobs	Modify and test the shell scripts that connect to database (using sqlplus for Oracle) with new connection details.
22	Batch processes	Modify and test batch processes that run on a scheduled interval so that they perform all CRUD operations on new database.
23	Application configuration	Modify the configuration file (generally system. Properties) of your web application to get connections from new database. Ideally this should be the only change in the App. But check for any hard-coded references to old database.
24	Database links	Test database links on new database server. Fully qualified path name of the server can lead to issues. Also, you can request a db link from old to new server and vice versa for getting more flexibility.
25	Relationship across the databases	Due to version upgrade, some of the database objects need to rewrite so if any relationship persist in any of the database out of 6 databases, need to take care of.
26	Other the databases	If you are using other databases to do some work, modify the processes to point to new database instance.
27	Schedule jobs	Test Oracle scheduled jobs on new database instance. Think about whether you want the jobs to still run at old db instance.
28	Oracle packages	Test advanced Oracle packages you are using. Eg: utl_mail, utl_file, etc.
29	Oracle directories	Think about Oracle directories you are using. If you are migrating your database to a different Unix server, the directories will have to be recreated. Test processes that reference the directories.
30	Performance	The new database will most likely give better performance. If that's not the case, notify the DBA about it. Keep an eye on the performance to see if it deteriorates.
31	Profile file	Modify your Unix profile file if you are loading any database related details.
32	Meta data	If you had access to Oracle dictionary tables in old database, make sure you can access those from new database.
33	Notification	Notify all users who are directly connecting to your database. Ideally you would want to give them a heads up before the migration to avoid any surprises/shocks
34	Backup plan	This is very important. Have a backup plan to roll back your code changes if database migration has some issues. You don't want your application to be unavailable (may be for few days) until the issue is fixed.
35	Table Row Count	Compare the table row count before and after cutover.
36	Mock Migration	Perform a mock migration and Test the application connectivity/compatibility/functionality.
37	New TNS Entry	Circulate the New TNS Entry for the upgraded/migrated Database.

38	CUTOVER	After the first level migration and test, need to schedule one or multiple timeline to do a cutover. After the cutover activity, all the applications will run with new database.
39	Post Cutover Health Check	Prepare shell scripts for DB health check after cutover.

- 2) The Envelope should contain 3 other bids namely EMD, Technical Bid, & Commercial Bid.
- 3) The complete tender document in sealed envelope should reach the office of the Director of Treasury, Accounts & Pension, Block 'A', 1st floor, Indrawati Bhawan, Nawa Raipur, Atal Nagar, Chhattisgarh-492002 on or before the last date and time given for bid submission by speed post or to be deposited by hand in tender box provided in DTAP office.
- 4) Bidders, who are Micro and Small Enterprises registered with District Industry Centers and small scale industries of Chhattisgarh along with valid startups registered with government and established as per industrial policy of 2014-19 annexure-1 defined in serial no. 54 or National Small Industries Corporation (NSIC) or any other body specified by Ministry of MSME are also exempted from submitting Tender Bid Security(EMD). Bidder shall submit copy of the valid registration certificate issued by the authorities as above and indicating the category of services, category of enterprises and the monetary limit for which they are registered, in the EMD bid.
- 5) In case bidder is not registered under MSME/NSIC, the EMD amount of Rs.6,00,000 should be submitted in the form of a DD payable to the Director, Treasury Accounts & Pension, Block 'A', 1st Floor Indravati Bhawan, , Nawa Raipur, Atal Nagar, Chhattisgarh.
- 6) Tender fee Rs.5000 to be paid in the form of a DD payable to the Director, Treasury Accounts & Pension, Block 'A', 1st Floor, Indravati Bhawan, Nawa Raipur, Atal Nagar, Chhattisgarh.

- B) 20% Remaining payment will be release post Migration services


## Refund of EMD :-


